Your application was selected for review in a process called "verification." In this process, we will be comparing information from your application with signed copies of your 2010 federal tax forms (and your spouse's if you are married, or parents' if you are considered dependent for federal aid purposes). Most applicants who receive this form have been selected for verification by the US Department of Education (DOE), which requires our office to ask you for this information before disbursing federal aid. The DOE allows our office to request this information from any applicant before awarding federal aid. If there are differences between your application and documents provided, Simpson will make the necessary corrections. Please complete verification as soon as possible and provide all information accurately and completely. Missing or incomplete information may result in delays to receiving your financial assistance.

WHAT YOU SHOULD DO:

1. Collect your (and your spouse's or parents') financial documents (signed federal income tax forms, W-2, Military LES, etc.).

3. **Read carefully and complete all sections that apply to you. Make sure you collect all required signatures.**

You are only considered to be an independent student IF you were born BEFORE January 01, 1988, OR are admitted into a degree BEYOND a Bachelor's degree, OR are married, OR have children for whom you supply MORE THAN ½ of their support, OR have other dependents who live with you AND receive MORE THAN ½ of their support from you, OR are an orphan/ward of the court OR are a veteran of the U. S. Armed Forces OR are currently serving on active duty in the U.S. Armed Forces for purposes other than training.
